If your income is **\$55,952 or less you may qualify for up to \$6,557 in Earned Income Tax Credit (EITC)** and if you paid someone to care for your child or other qualifying person so you (and your spouse if filing jointly) could work **or look for work**, you may be able to claim the **Dependent Care Credit**. To qualify, you must file a tax return and meet certain income and other requirements.
